AMENDMENT NO. 3 TO SCHEDULE 13D

This Amendment No. 3, dated May 12, 2003 to Schedule 13D is filed by the Reporting Persons and amends the Schedule 13D/A as previously filed by the Reporting Persons with the Securities and Exchange Commission on May 12, 2003, relating to the common stock, \$.001 par value (the "Common Stock") of LIVEPERSON, INC., a New York Corporation.

Items 3 and 5 and Exhibit A of the Schedule 13D/A are hereby amended and restated, as follows:

ITEM 3 SOURCE AND AMOUNT OF FUNDS OR OTHER CONSIDERATION

As of May 12, 2003 Hummingbird has caused each of HVF and Microcap Fund to invest approximately \$557,910 and \$291.070, respectively, in the Shares of the Issuer using their respective working capital. Sonkin has invested \$5,407 in Shares of the issuer using Personal Funds.

ITEM 5 INTEREST IN SECURITIES OF THE ISSUER

- (a) The Reporting Persons aggregately beneficially own 1,498,747, or 4.4% of the Common Stock of the Issuer, based upon 34,152,131 shares outstanding as of March 15, 2003, as reported on the latest 10-K of the Issuer.
- (b) Hummingbird has shared voting power over 1,498,747 Shares of the Issuer.

Hummingbird has sole dispositive power over 1,486,347 Shares. As the holder of sole voting and investment authority over the Shares owned by HVF and the Microcap Fund, Hummingbird may be deemed, for purposes of Rule 13d-3 under the Securities Exchange Act of 1934, as amended, to be the beneficial owner of the aggregate amount of 1,486,347 Shares of the Issuer. Hummingbird disclaims any economic interest or beneficial ownership of the Shares covered by this Statement.

Mr. Sonkin is the managing member and control person of Hummingbird, and for purposes of Rule 13d-3 may be deemed the beneficial owner of such Shares deemed to be beneficially owned by Hummingbird. Thus, Mr. Sonkin may be deemed, for purposes of Rule 13d-3, to be the beneficial owner of 1,486,347 Shares of the Issuer Mr. Sonkin disclaims any economic interest or beneficial ownership of these Shares.

Mr. Sonkin is also the owner of 12,400 Shares and has sole dispositive power over 12,400 Shares. He has shared voting power over 1,498,747 Shares.
